Privacy Policy

The European Pancreatic Club (EPC) protects the personal data of the EPC website users with greatest diligence. Personal data are data which can be related to your person and provide information on your behavior or characteristics. This includes of course your name, postal address, telephone number and email address as well as information about your possible interests and surfing customs as far as this information can be attributed to you directly or indirectly. I. Non-personal data

In the course of your access to our websites or to files provided on our websites data will be logged for internal system-related and statistical purposes which possibly allow identification (name of the file accessed, date and time of the access, data volume transferred, notification of successful access and transfer, web browser and requesting domain). Person related exploitation will not be conducted. Statistical analysis of data made anonymous is reserved.

II. Collection, use and processing of personal data for the use of our online services

We use and process these data only for the purpose of answering your requests, for executing contracts that have been concluded between you and EPC and for technical administration. Your personal data will only be disclosed or otherwise transferred to third parties if this is necessary for executing contracts or other agreements (for example online access to material from EPC member societies), for accounting purposes or if you have given your explicit consent.

III. Visibility of your personal data for other users

By giving consent to the using and processing your data you agree to the publication of your data (e.g. name, postal address, email address) to other users so that they become visible to them.

IV. Data safety

Your data will generally be transferred to us in an encoded form to exclude access by unauthorized third parties. Your data will be stored on secured servers. They are only accessible to authorized persons who are familiar with the applicable data protection provisions. However, we can not guarantee the security of the data and be liable for damages, in consequence to unauthorized access, hardware and software defects and other factors which may prejudice data security at any time.
